<u>Collection of personal information and its use -</u> The Art Apprentice Online LLC may ask you to register for our newsletter, for an artist's survey or when necessary information is collected to process your order. The Art Apprentice Online is the sole owner of the information that is collected on this website. We will not rent, sell, lease or disclose or share any of this information to any other person or entity or use the information for any other purpose other than for which it is collected as stated in this privacy statement.

<u>Security -</u> When customers provide us with sensitive information via our web site, it is protected online as well as offline. The Art Apprentice Online has taken every precaution to help protect the information our customers provide us with. The sensitive information that is provided to us is tightly controlled by the founders of the Art Apprentice Online management. No one else has access to any of this information.

<u>Orders -</u> The Art Apprentice Online collects information to process orders from our shopping cart; if there is any difficulty in processing or filling an order, we use the information provided to contact the customer. <u>Cookies -</u> An Http: 'Cookie' is a piece of data that is stored by your browser in either your computer's memory or on your computer's hard drive, these are called *session cookies*. Browsers generally allow you to disable cookies.
